Event Accommodation

Overnight accommodation is not included in the registration fee. However, reduced rates have been negotiated at the Marriott World Hotel. It is advisable to book early to secure these rates, as availability is not guaranteed. Provision of valid credit card information is required at the time of booking in order to guarantee a hotel room booking, and all costs will be charged to the individual at the hotel. Please note the credit card must have an expiration date post the last day of the IFS Unleashed 2024 event.

Travel

Travel is not included in the registration fee. It is the responsibility of the Attendee to make their way to the conference venue in adequate time. IFS will not be liable for any delays or non-attendance resulting from delayed or suspended transportation.



Information Required by the Attendee

Conference Ticket / Training Ticket Cancellations

All cancellation notifications should be emailed to <u>IFSevents@delegate.com</u>. Please allow four (4) weeks for the processing of any approved refund.

A cancellation fee of 3% on paid ticket price will be charged for all general conference tickets / training tickets cancelled more than 90 days before the event. Cancellations made after this date will be subject to the following refunds:

- 90-61 days prior to the event: 50% refund of conference fee paid / training ticket fee paid
- 60-31 days prior to the event: 25% refund of conference fee paid / training ticket fee paid
- 30 days, no financial refunds or credits will be provided for cancellations.

Cancellation of tickets within 4 for 3 offer

If 1 ticket is cancelled, the value of the other 3 tickets becomes chargeable at \$1999, and the standard terms and conditions are applied.

Substitutions and Name Changes
